Spring is the time of plans and projects. While Assemblies and Councils have temporarily cancelled physical meetings, there is absolutely no reason that the leadership cannot set up a group phone call or “Go-To Meeting” to discuss financials, as well as where you’ll need to jump into action, when the nation gets back on track. We never sleep ... and must be ready to act on a moment’s notice. Be creative!

**During these trying times, remember ...** Listen and follow the directions of your State and local authorities. If you feel sick, stay home. Do not go to work. If your children are sick, keep them at home. Contact your medical provider. If you are an older person, or have a serious underlying health condition, stay home and away from other people. If someone in your household has tested positive, keep the entire household at home. Work or study from home whenever possible. Avoid social gatherings in groups of more than 10 people. Avoid eating or drinking at bars and restaurants – Use pickup or delivery options. Avoid discretionary travel, shopping trips and social visits. Do not visit nursing homes or retirement or long-term care facilities unless to provide critical assistance.

**Always practice good hygiene.** Wash your hands, especially after touching any frequently used item or surface. Avoid touching your face. Sneeze or cough into a tissue, or the inside of your elbow. Disinfect frequently used items and surfaces as much as possible.

Always know that Jolene and I will be thinking of you and praying for you and your families and friends.

Worthy Brother Knights,

I received a communication from our Regional Growth Director Eric Johnson that they have been hearing of various councils in some jurisdictions that are refusing to listen to the strongly recommended suggestions of the Supreme Council.

RGD Eric Johnson has provided the follow-up statement issued from the Supreme Office.

*"The Supreme Council strongly recommends that all meetings, events, and travel be cancelled until further notice.*

*We understand your concern about the cancellation of long-planned meetings and events. However, the coronavirus pandemic must be taken seriously, especially its lethal effect on the sick and elderly. Currently, the only known effective prevention measures involve social distancing to prevent person to person spread of the disease.*

*For these reasons if your council or assembly chooses to host gatherings of any nature, please be fully aware of the risks that such events pose to your members and guests. In making a determination as to whether to proceed, you should consult with your pastor and follow all guidelines, recommendations, and restrictions of the diocese and local civil authorities. Additionally, you should review and follow the guidelines for gatherings and events that are available on the Centers for Disease Control website ([www.cdc.gov](http://www.cdc.gov)). In light of the seriousness of this pandemic and the consequences of exposure, you should take all possible measures to minimize risks and prevent inadvertent spread of coronavirus. Recognize that you if you decide to proceed with your meeting or event, you must assume responsibility for the health and safety of your attendees."*

I would like to believe that our leaders throughout New Hampshire are heeding the seriousness of the situation we find ourselves in, and that we would put forth the measures necessary to protect our brother Knights, their families, and our local parishioners.

Your State Council and Supreme Council continue to closely monitor COVID-19 developments, and we will provide updated information and guidance as it becomes available.

I would like to personally express my heartfelt thoughts and prayers to those dealing with the COVID-19. It is in time of crisis like this that the Order's watch words of Charity, Unity, and Fraternity are exemplified by my Brother Knights. God Bless.

## ***A SPECIAL VAVS REPORT***

Brother Sir Knights,

Our military personnel voluntarily act as the protectors of our nations, standing on the front lines while keeping us safe behind them.

The Knights of Columbus acknowledges this unselfish act of patriotism by promoting the “Serving Those Who Served” program. There are 26 million U.S. veterans and hundreds of thousands of men and women currently serving in the military. Meeting the needs of such a large population is the Veterans Health Administration (VHA) of the Department of Veterans Affairs, which operates more than 1,000 facilities throughout the United States, ranging from full-service hospitals to nursing homes and home-care programs.

The U.S. Department of Veterans Affairs Veterans Affairs Voluntary Service (VAVS) Program is the vehicle that the Knights of Columbus uses in the Serving Those Who Served program. The Vice President for Fraternal Mission has oversight of the VAVS program. The program is directed and managed by the Assistant for Military and Veterans Affairs who also serves as the National VAVS Representative to the VAVS National Advisory Committee (NAC). The K of C VAVS program is executed through the Fourth Degree chain of command through the U.S. Vice Supreme Masters and District Masters. Under the program, a Knight of Columbus is certified as a VAVS representative or deputy representative at a VA medical center. Our certified representatives and deputy representatives attend hospital meetings and organize efforts for K of C volunteers.

The Knights of Columbus currently has VAVS representatives at almost every VA medical center (VAMC) and many clinics in the United States. There is one certified representative and, up to, three deputy representatives from the Knights of Columbus at these VAMCs. Representatives recruit and manage K of C VAVS volunteers in developing activities and programs that target the most essential needs of the patients.

In the United States, the VA hospitals, clinics and facilities need all types of volunteer services – from program planning to visiting veterans. For more information on this outstanding program, please contact your Fourth Degree District VAVS Representative, **Robert Garand**.

The philosophy behind “Serving Those Who Served” is simple: the men and women of the Armed Forces didn’t let the Nation down on the battlefield, and the Knights of Columbus will not let these veterans down now.

## ***IMPORTANT BENEFITS SURVIVORS SHOULD KNOW:***

### **Pension**

Survivors of veterans who served during wartime can apply to receive a tax-free pension, known as a Survivors Pension or Death Pension. The pension provides a monthly payment to surviving spouses with modest incomes who have not remarried. The benefit is also available to unmarried dependent children of wartime veterans.

The amount of the pension is set each year by Congress and eligibility is determined by a complex calculation that considers net worth as well as various kinds of income and expenses. What counts as income can be reduced, for example, by certain expenses, such as unreimbursed medical care. For surviving spouses without a dependent child, the maximum annual pension is currently about \$9,000.

Those who are homebound or who require assistance for basic daily activities may qualify for an additional payment.

### **Burial Benefits**

Eligible veterans and their spouses and dependents can be buried in one of the 136 national cemeteries maintained by the VA. Burial benefits for veterans in these cemeteries include opening and closing of the grave, perpetual care, a Government headstone or marker, a burial flag, and a Presidential Memorial Certificate (PMC), at no cost to the family. Burial benefits available for



spouses and dependents buried in a national cemetery include burial with the veteran, perpetual care of the gravesite, and the spouse or dependents' names and dates of birth and death inscribed on the veteran's headstone, at no cost to the family. Eligible spouses and dependents may be buried in a VA national cemetery even if the veteran is not buried there.

When veterans are buried at private cemeteries, the government provides a headstone or marker, a burial flag, and a PMC. The VA also may pay for some of the burial and funeral expenses. Many states have state veteran cemeteries, which may have residency requirements.

### **Life insurance**

Veterans who receive a disability rating connected to their service can qualify for a Service-Disabled Veterans Insurance (S-DVI) life insurance policy, which provides up to \$10,000 of coverage. Veterans who are totally disabled are eligible to have their premiums waived.

Totally disabled veterans who are approved for a premium waiver can apply for up to \$30,000 in additional coverage, but premiums for the supplemental coverage cannot be waived.

***VETERANS BENEFITS ADMINISTRATION ANNOUNCEMENT:***



The Veterans Benefits Administration (VBA) Regional Offices will be closed to the public starting March 19th

Regional offices will remain open, but will no longer accept walk-ins for claims assistance, scheduled appointments, and counseling and other in-person services. This decision protects our older Veterans and those with underlying conditions as well as our employees.

VBA benefits and services provided to Veterans, families, and survivors will continue to be delivered throughout the duration of COVID-19 impacts.

## ***USO ON FRONTLINES OF COVID-19 BATTLE:***



We know the spread of the novel coronavirus COVID-19 has created uncertainty and challenges for every American family, including your own. Although the battle against this unseen enemy is just ramping up stateside, our military heroes and families have already been on the front lines for weeks, battling this invisible, aggressive enemy from our bases overseas.

### **A “New Normal” for U.S. Troops Abroad:**

U.S. bases in hard-hit European and Pacific countries rapidly implemented COVID-19 precautions, but these safety measures came at a cost:

- Many troops and families are restricted to base, leaving them disconnected.
- Some troops are under precautionary quarantine, leaving them feeling isolated and alone.
- On-base schools and daycares have been closed.
- Community gatherings have been restricted.

### **New Strains on USO Staff & Services:**

USO staff are addressing a three-pronged crisis: a dramatic surge in troop and family need; their own risk of infection; and the challenge of completely retooling traditional, face-to-face programs and services on the fly. I am incredibly proud of our team’s creativity and absolute determination to mobilize for our troops. We are:

- Investing in protective gear for USO staff — \$50,000 so far.
- Doing everything possible to keep some local USO centers open in outbreak hotspots, and even extend their hours. This is at the express request of military leaders. USO centers at Naval Air Station Sigonella in Italy, Camp Aachen in Germany, Camp Walker in South Korea and in Erbil, Iraq are among our overseas centers that currently remain open.

### **Military Action to Battle U.S. Outbreaks:**

Our military has also begun to deploy its resources stateside:

- [Hospital ships USNS Comfort and USNS Mercy will be sent to New York and the west coast<sup>1</sup>](#) to relieve strain on state healthcare systems.
- [Governors of 22 states have called up 1,500 Army and Air National Guard to active duty, with more to come.<sup>3</sup>](#)

There’s still a long road ahead. That’s why we are so grateful for supporters like you.

VA bills the Veteran for a copayment, if applicable.
